This document highlights changes to the July 2010 *Charles Schwab Hong Kong Pricing Guide for Individual Investors* ("Pricing Guide").

Commissions and Transaction Fees¹

Effective September 1, 2012, fees for broker-assisted trades of foreign stock are changing.

- **For broker-assisted trades of foreign stock placed exclusively on the U.S. over-the-counter market:** The fee will change from the greater of US\$100 or 0.5% of principal, with no maximum, to a flat fee of US\$83.95 per trade (US\$8.95 base fee plus a US\$25 broker fee, plus a US\$50 foreign transaction fee).
- **For broker-assisted trades of foreign stock placed exclusively on a foreign exchange or on a foreign exchange and on the U.S. over-the-counter market simultaneously:** The fee will change from the greater of US\$100 or 0.5% of principal, with no maximum, to the greater of US\$100 or 0.75% of principal, with no maximum.

由2012年9月1日起，經紀協助之外國股票交易費用將更改如下。

- **僅於美國場外市場進行的經紀協助之外國股票交易：**費用將由\$100美元或本金的0.5%(以較高者為準及不設上限)，調整為每宗交易一律\$83.95美元(基本費用\$8.95美元，加\$25美元經紀費，另加\$50美元外國交易費用)。
- **僅於外國交易市場，或同時於外國交易市場及美國場外市場進行的經紀協助外國股票交易：**費用將由\$100美元或本金的0.5%(以較高者為準及不設上限)，調整為\$100美元或本金的0.75%(以較高者為準及不設上限)。

Account Activity Fees

- The fee for ordering out securities held electronically through the Direct Registration System will continue to be US\$0 per issue. The fee for ordering out physical certificates of all U.S. and some Canadian securities will change from US\$50 per certificate. Effective September 1, 2012, the fee will be equal to the amount charged to Schwab by the Depository Trust & Clearing Corporation (currently US\$500 per physical certificate, subject to increases in the future). Additional charges may apply for rush requests.

Custody Fees

- Effective immediately, there is no fee to custody physical certificates. Previously, the listed custody fee was US\$50 per year per position.
- The following fees will apply to non-publicly traded securities:
 - Ineligible security fee: Effective September 1, 2012, an annual fee of US\$250 per position will be charged for continued servicing of non-publicly traded securities that are ineligible for custody at Schwab. There is no per-account maximum on this fee. Clients will be notified in advance if any of their holdings are subject to this fee.
 - Valuation fee: Effective September 1, 2013, an annual fee of US\$500 per position will be charged to offset the costs of a third-party appraisal, if one is available, if standard valuation sources fail to provide a year-end fair market value for a non-publicly traded security. There is no per-account maximum on this fee. Clients will be notified in advance if any of their holdings are subject to this fee.

帳戶活動收費

- 透過直接註冊系統(Direct Registration System)提取以電子方式持有的證券，費用仍為每項\$0美元。提取所有美國及部分加拿大證券的實物證明書，費用將不再為每張證書\$50美元。由2012年9月1日起，有關費用將調整至美國存管信託及結算公司(Depository Trust & Clearing Corporation)向嘉信理財所收取的同等金額(現為每份實物證明書\$500美元，未來或再上調)。如屬緊急要求，則可能收取額外費用。

託管服務費

- 託管實物證明書不設收費，並即時生效。之前的託管費用為每項持倉\$50美元年費。以下費用適用於非公開交易證券：
 - 不合資格證券的費用：由2012年9月1日起，就不符合嘉信理財託管服務資格的非公開交易證券，如須繼續託管，則必須繳付每項持倉\$250美元的年費。此費用並沒有就各帳戶設定上限。如客戶所持有的任何證券須繳付此費用，將事先獲得通知。
 - 估值費：由2013年9月1日起，如標準估值來源不能為非公開交易證券提供公平的年終市值，嘉信理財將就每項持倉收取\$500美元年費，以抵銷第三方的評估費用(如適用)。此費用並沒有就各帳戶設定上限。如客戶所持有的任何證券須繳付此費用，將事先獲得通知。

Special Service Fee Waivers

Effective September 1, 2012, the fee for ordering out physical certificates of all U.S. and some Canadian securities may be waived for households that meet certain asset levels or trading activity minimums. Previously, this fee was automatically waived for households with US\$500,000 or more in balances, or 36 or more stock or options trades per year.

Custody Fees

Effective May 1, 2010, the new pricing for alternative investments is as follows:

Fee	Amount
Alternative investments*	\$250 annual maintenance fee per position; \$500 maximum per account \$100 transaction fee

*Alternative investments include (list is subject to change): promissory notes; limited partnerships; private limited partnerships; limited liability companies; private common, preferred, and convertible preferred stock; private bonds; private warrants; private placements; and private REITs. State of Israel bonds and church bonds, which are considered non-standard assets, are subject to the \$100 transaction fee only.

Fee Collection Process

The custody fee billing process for alternative investments is changing from an advance annual billing to an annual billing in arrears. The new custody fees will apply beginning May 1, 2010, and will be charged annually as follows:

- At the end of September 2010, or shortly thereafter, a partial year's billing (five-twelfths) of the new custody fee will be charged for the period of May to September 2010.
- At the end of September 2011, the full custody fee will be charged for the period of October 2010 to September 2011, and annually thereafter.

收費程序

- 於2010年9月底或稍後，就2010年5月至9月這期間的服務，將收取該年度的部份(5/12)寄存服務新收費。
- 於2011年9月底，就2010年10月至2011年9月這一年期，將收取全數寄存服務費，此後將每年收費。

Special Service Fees

Exchange Process Fee—This is a fee Schwab charges to offset fees imposed on us by national securities and self-regulatory organizations or by U.S. option exchanges.

The Securities and Exchange Commission (SEC) assesses transaction fees on national securities exchanges and self-regulatory organizations based on the aggregate dollar amount of sales of certain securities. The SEC recalculates the amount of this fee periodically—at least once per year but sometimes more often. National securities exchanges and self-regulatory organizations offset the transaction fees by charging their member broker-dealers such as Schwab, and we, in turn, offset this fee by charging you an Exchange Process Fee for covered sell transactions.

U.S. option exchanges charge Schwab and other broker-dealers per-contract fees for purchases and sales of exchange-listed options. The exchanges may charge these fees even on transactions executed on other exchanges, which can result in multiple fees being imposed on Schwab for a single transaction. Schwab offsets these fees by charging you a single Exchange Process Fee for each covered transaction.

After October 1, 2010, any Exchange Process Fee that appears on your trade confirmation for a sale of an exchange-listed option will combine the offsets for the fees charged both by the U.S. option exchanges and by the national securities and self-regulatory organizations.

Schwab's Exchange Process Fee will rise or fall periodically depending upon the rates set by the SEC or by the U.S. option exchanges, as applicable.

Transaction Fee—This fee includes either fees charged for purchases and sales of certain offshore mutual fund shares or fees charged for purchasing U.S. Treasury obligations via the auction process. The amount of this fee will appear on your trade confirmation.

American Depositary Receipt (ADR) Fee—Banks that custody ADRs are permitted to charge ADR holders a fee. Fees collected from Schwab by the Deposit Trust Company for an ADR will be automatically deducted from your Schwab account(s) and shown on your statement(s) as “ADR Pass-Thru Fee”.

特別服務費

交易處理費—這是嘉信理財為抵銷全國性證券交易所及自律監管機構或美國期權交易所向我們徵收的收費，而向閣下收取的費用。

美國證券管理委員會(SEC)根據部分證券的合計銷售金額評定全國性的證券交易所及自律監管機構的交易費用。美國證券管理委員會定期重新計算此費用—最少一年一次，有時較此為多。全國性的證券交易所及自律監管機構通過向其會員經紀經銷商如嘉信理財收取費用以抵銷交易收費，我們因而就所涵蓋有價證券沽售交易收取交易處理費以抵銷此費用。

美國期權交易所向嘉信理財及其他經紀經銷商收取買賣交易所上市期權的每張合約費用。即使交易於其他交易所進行，交易所亦可能會收取此等費用，令嘉信理財就單一交易被徵收多重費用。為抵銷此等收費，嘉信理財就每一所涵蓋有價證券沽售交易向閣下收取單一交易處理費。

於2010年10月1日後，任何列明於閣下交易確認書上的交易所上市期權沽售交易處理費，將綜合用以抵銷由美國期權交易所、全國性證券交易所及自律監管機構所收取費用的金額。

嘉信理財的交易處理費將按美國證券管理委員會或美國期權交易所(根據情況)釐訂的費率定期做上下調整。

交易費用—此費用包括部分離岸互惠基金股份的買賣費用或經拍賣購買美國國庫債券的費用。此等費用將於您的交易確認書上列明。

美國預託證券收費—託管美國預託證券的銀行獲允許向美國預託證券持有人收費。存款信託公司(Deposit Trust Company)向嘉信理財收取的美國預託證券費用將自動從您的嘉信理財帳戶扣除並於您的月結單上顯示為「美國預託證券費用」(“ADR Pass-Thru Fee”)。

Special Service Fee Waivers

- Security order out and security reorganization fees: Fees are waived with \$500,000 or more in Household Balances or 36 or more stock or option trades per year in Accounts of Your Household.
- Wire transfer fee: With \$500,000 or more in Household Balances, or 36 or more stock or option trades per year in Accounts of Your Household, you will receive three free U.S. domestic wire transfers per quarter.

- ¹ Excluding offshore mutual funds, commissionable trades that execute over more than one day will be charged a separate commission for each additional day; each separate commission will apply to the portion of the trade executed on the corresponding additional day. Trade orders for which price or quantity are changed by the client and, as a result, execute over multiple trades on the same day are each charged a separate commission.
- ² Up to 999,999 shares can be placed per trade.
- ³ Standard fees apply on both transactions when placing simultaneous orders to sell one or more transaction-fee fund(s) and purchase additional transaction-fee fund(s) with the proceeds.
- ⁴ Schwab's short-term redemption fee will be charged on redemption of funds held for 90 days or less. Schwab reserves the right to exempt some funds from this fee, such as funds that accommodate short-term trading.
