Foreign wires that are subject to U.S. federal regulation must be confirmed by you or your agent by telephone. Until that occurs, you will not be deemed to have provided us with a wire request. If there is any difference between your telephonic instructions and the information set forth in this form, we may act on your telephonic instructions. To avoid delay, please complete all required fields and provide all telephone numbers requested in Section 1.

Please note: Accuracy is important. If you describe any beneficiary or financial institution by name and account or identifying number, we and other institutions may process the wire based solely on the number, even if it identifies a different person or entity. If you provide an incorrect account number, you could lose the amount transferred. We may refuse to act upon any instructions that we cannot verify as accurate and authorized by you.

Authorized Persons. We may accept/confirm wire requests from any person with signing authority on your Schwab account. Any person with signing authority may change or revoke this verification. We can require you to execute a new verification at any time.

Agreement. Wire transfers are subject to the terms of your Schwab Hong Kong U.S. Dollar Account Agreement. If you do not have sufficient available funds in your account at the time of your proposed transfer, your wire may be rejected or delayed. Please note that wiring funds outside of the U.S. may take up to seven business days to complete.
